## POLICIES AND PROCEDURES

- Children must be at least five years old **AND** in kindergarten to ride the bus.
- Family rates apply for multiple students.
- One-way riders contract for either A.M. or P.M. routes for the semester.
- Contract riders are invoiced approximately two months prior to each quarter.
- Riders may be added after the quarter starts at the full quarter price.
- Once a rider is enrolled, **any changes must be communicated in writing to [transportation@pinecrest.edu](mailto:transportation@pinecrest.edu).**
- Transportation is **AUTOMATICALLY RENEWABLE** each subsequent quarter and year until the **CANCELLATION FORM** (available at [www.pinecrest.edu/transportation](http://www.pinecrest.edu/transportation)) is completed, signed, and emailed to [transportation@pinecrest.edu](mailto:transportation@pinecrest.edu). All communication must be in writing and signed by a parent or guardian and submitted **BEFORE** a quarter begins in order to keep from being billed for that quarter. Once a School quarter begins, there are no refunds. In addition, prorating is not offered if you sign up after a quarter begins.
- Routes may be subject to stop or time changes based on need.
